THIS AGREEMENT, made and entered into this date by and between **Let's Bowl, LLC**

hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease to issue the Notice to Proceed for Change Orders #10 and #11 to the construction of the Tenant Improvements and provide for a lump sum payment for the Tenant Improvements allowance overage for the Government.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective February 1, 2012 as follows:

A. Let's Bowl, LLC is hereby authorized to begin construction of the Tenant Improvements for the Government in the agreed upon amount of \$15,762.00 (Change Order #10 = \$13,479.00 and Change Order #11 = \$2,283.00) in accordance with all Lease requirements, the Design Intent Drawings, Construction Drawings, and fixed price proposals entitled Change Order #10 dated November 22, 2011 and Change Order #11 dated November 23, 2011, (incorporated by reference). The Government will pay a one-time lump sum payment upon completion and acceptance of the improvements in the amount of \$15,762.00.

Upon completion of the work, the Lessor shall notify the contracting officer to arrange for an inspection. After inspection and acceptance of the work by the Government, a properly executed invoice shall be submitted at:

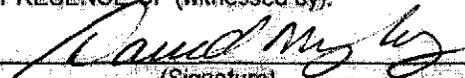

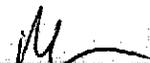
