With increased populations in urban areas come **increasing demands for services and the need for more effective and responsive local-level governments.**

Local governments are often more nimble than national-level governments and are in **closer proximity to the people they exist to serve.** This makes the impact they have through participating in OGP more meaningful.

Open Government is a paradigm based on values, that seeks to transform the relationship between citizens and government...



Open Government is

- collaborating to address difficult problems.
- co-creating impactful public policies
- recognizing the role of citizens, build on what has been achieved and seek alliances.
- working to promote human rights.
- fighting corruption and improving public services.

The role of citizens and civil society in open government

(...) the involvement of citizens and civil society is critical to developing, securing and implementing open government reforms and that reformers inside and outside governments must build **broad coalitions** to achieve change.

(...) citizens are no longer passive receptors of government information, to the contrary, **governments and citizens engage** in a joint construction of value.

Through the **OGP action plan** we put this central idea into action.



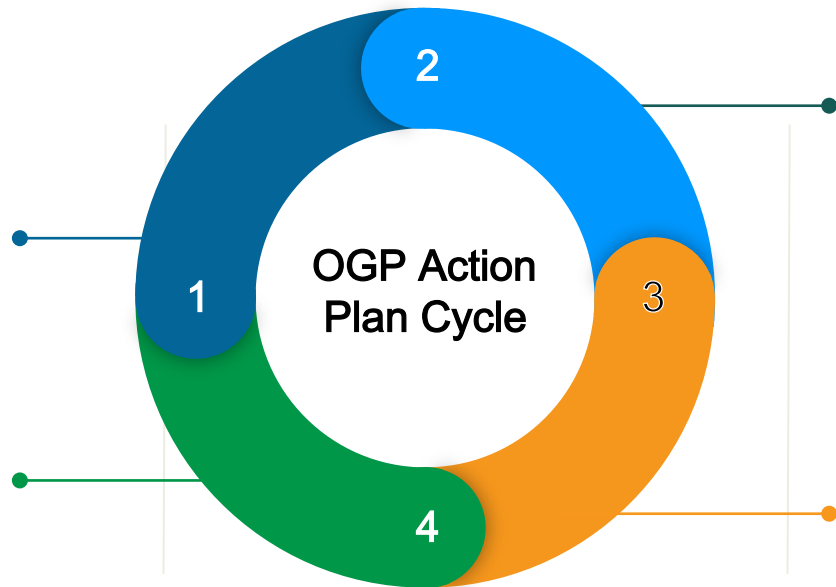
OGP's ways of achieving its goals

Joining OGP

Governments join OGP to implement open government reforms.

Tracking, assessment and recommendations

The **Independent Monitoring Body** monitors action plans to measure progress on commitments and presents recommendations for improvement.



Co-creation of action plans

Governments and civil society organizations work together to co-create action plans.

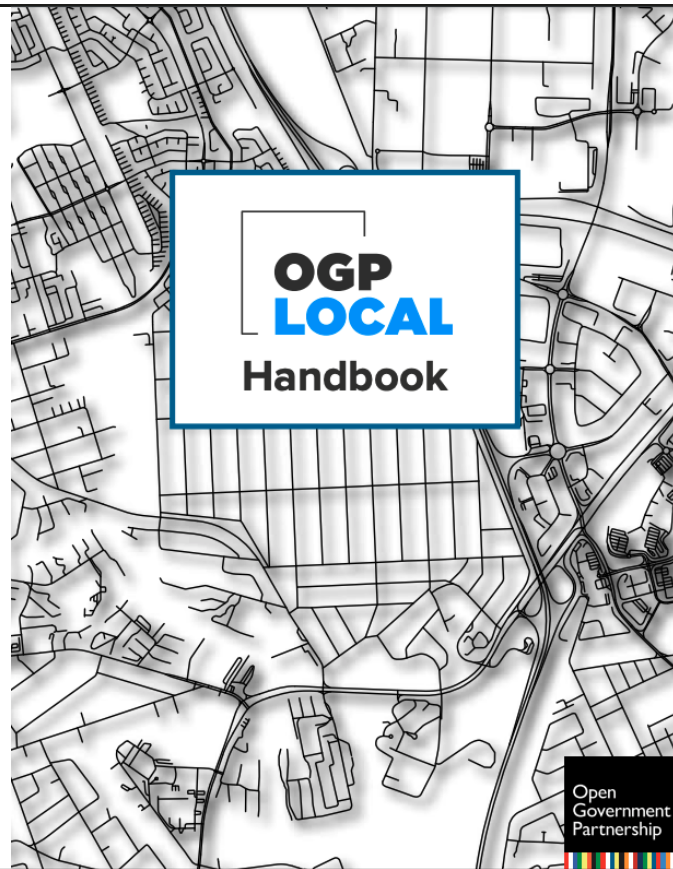
Implementation of action plans

Governments work with civil society to implement the commitments of the action plans.

Local

Adaptable, responsive, flexible

- 1 action plan period the length of an administration.
- Up to 5 commitments at any one point.
- Local members must select an independent monitoring body.
- Assessments to promote learning

- Action plans are at the core of participation in OGP.
- Governments and civil society co-create **OGP action plans**.
- Action plans have **concrete open gov commitments or reforms** across a range of issues.

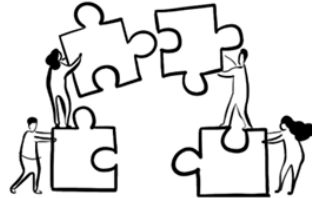

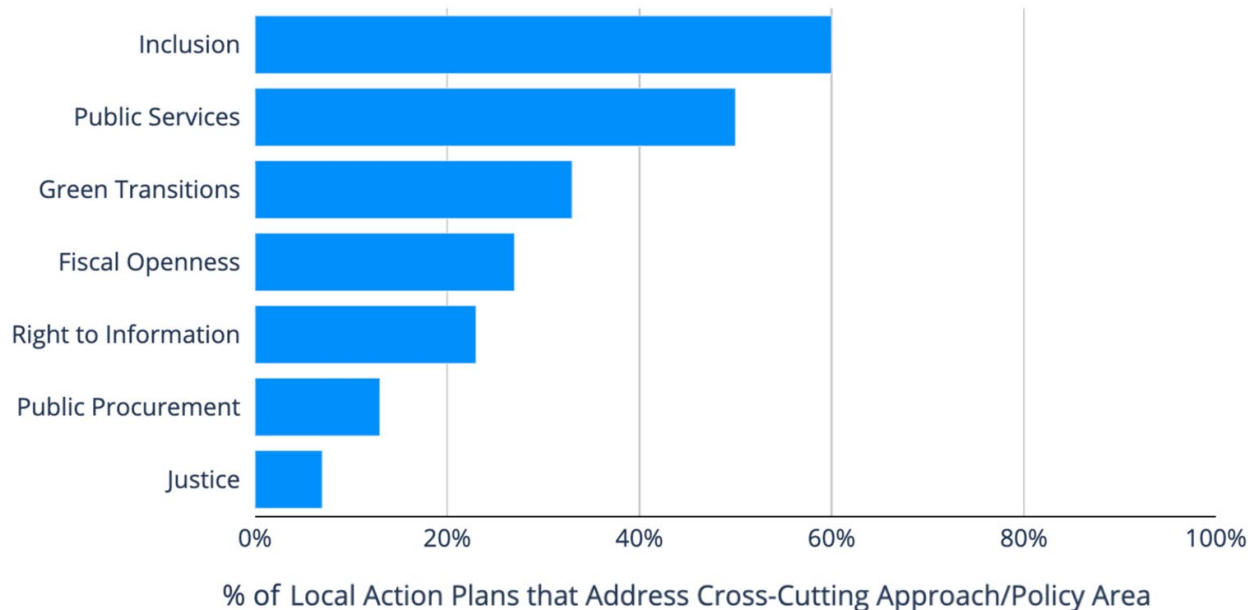


OGP ACTION PLAN

Madrid, Spain

The perception of corruption had grown remarkably in Spain and, in Madrid questions had been raised about public procurement. There was no registry of actors involved in decision-making.

Creation of a Mandatory Lobby Registry +

Madrid created a **lobby registry** . Since its launch, the number of registered lobbies has risen from zero to over six hundred, showing the success of the process.



Bogotá, Colombia

The gaps between men and women in political and citizen participation in Bogotá are wide; only 26.6% of the seats on the Local Administrative Boards and 33% of the District Council are held by women.

Bogotá published **statistical information**, promoted **parity as a democratic principle**, created a District Multiparty Gender Roundtable, and promoted **gender-sensitive participatory budgets**.



Banggai, Indonesia

The percentage of pregnant people accessing minimum standards of care in Banggai fell from 94% to 87% from 2019 to 2020, leading to a 270% increase in birthing mortality.

**Online App to Achieve
minimum service standards
for pregnant women** +

Banggai, co-created an app that allows health workers to monitor the condition of pregnant women in real-time. **Users participated in the design of a plan to improve the app's data privacy** and now recommending it.
