- 48. As identified in Tenant Work Request (TWR) No. 138; The Government and the Lessor have agreed to the following number of overtime hours during construction with all government associate cost repaid via a credit to the government. This credit will be use for future government needs that will be paid by the Lessor.
- 296 hours have already been provided by the Government as of the date of this SLA; at a rate of \$44.14 per hour: Credit to the Government for these hours provided is: \$13,065.44
- 670 future hours for Saturday work provided by the Government at a rate of \$44.14 per hour:

 Credit to the Government for these hours provided is: \$29,573.80
- 180 future hours for Sunday work provided by the Government at a rate of \$44.14 per hour:

 Credit to the Government for these hours provided is: \$7,945.20

TOTAL CREDIT TO THE GOVERNMENT IS: \$50,584.44 FOR 1,146 HOURS OF OVERTIME

It is agreed that the Lessor will provide at least 7 days notice to cancel any overtime request. Hours of overtime for weekdays: 6:00 am to 5:00 pm (gates close at 5:00 pm)

Hours of overtime for Saturday and Sunday: 6:00 am to 3:00 pm (gates close at 3:00 pm)
