"7.69. Upon completion, inspection, and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of \$6,637.42 pursuant to Paragraph 7.70, herein. The Lessor hereby waives restoration as a result of all improvements."
