24. The total cost for Tenant Improvements in the amount of \$5,054,777.00 exceeds the tenant improvement allowance for \$1,186,616.04) and \$1,820.98) totaling \$1,828,437.02, which has been amortized into the rental rate. The Government hereby orders the excess balance \$2,426,588.96, \$799,751.02) in the amount of \$3,226,339.98. The Lessor shall construct all Tenant Improvements in accordance with Paragraph 5.14G of the Solicitation for Offers, incorporated and made a part of the Lease, and all terms and conditions of the lease package. Upon completion, inspection, and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of \$3,226,339.98 pursuant to Paragraph 25, herein. The Lessor hereby waives restoration as a result of all improvements.
