


NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective 9/23/14 Paragraph 27 is hereby added: Α. "27, REIMBURSALBE ITEMS: The Lessor hereby agrees to repair and maintain curb section, exterior column brick and cracked lobby floor tile damaged during the move-in. The Government agrees to reimburse the Lessor a total of \$7,218.98 upon receipt of an acceptable itemized invoice from the Lessor. Payment shall be forwarded to: GSA BILLINGS, L.C. 90 SOUTH 400 WEST, SUITE 200 SALT LAKE CITY, UT 84101-1365 The vendor receiving payment shall issue the invoice. Additionally the invoice shall include a unique invoice number and cite the following PDN number PS0030006. (Invoices submitted without the PDN number are immediately returned to the Vendor.) Invoices shall be submitted to the Greater Southwest Finance Center (with a copy to the Lease Contracting Officer) electronically on the Finance website at www.finance.gsa.gov.
